

## Dream Trip to Dubai Campaign Terms and Conditions

### 1. Preamble

These “Terms and Conditions” are made **between** INGOT Financial Brokerage Ltd. (hereinafter referred to as “the Company”), a limited liability company registered under the Companies Control Department of the Ministry of Industry, Trade and Supply with registration number “13014” and its registered address is Um Uthaina, 5 Saeed Abu Jaber Street, P.O. Box: 2126 Amman 11941, Jordan. The Company is authorized by the Jordan Securities Commission to practice the business of financial brokerage for the account of third parties in foreign stock exchanges, with the Approval Letter No. 3/1/02165/20 dated 17/12/2020 **and**;

Participants in the “Dream Trip to Dubai” campaign (“Participant(s)”, “Client(s)”, “You”, “Your”). These Terms and Conditions set forth the terms of participation in the Dream Trip to Dubai campaign (the “Campaign”) organized by the Company by virtue of the Ministry of Industry, Trade and Supply’s approval letter No. **393517-1-2024**.

By participating in the Campaign, you agree to be bound by these Terms and Conditions.

### 2. Campaign Period

The Campaign will run from February 15<sup>th</sup> to March 31<sup>st</sup>, 2024 (“the Campaign Period”). Any trades placed outside of the Campaign Period will not make the client eligible for participating in the Campaign.

### 3. Eligibility

For the Participant to be eligible to enter the Campaign, the Participant must meet the conditions below:

- The Participant must be at least 18 years old.
- The Participant must be a Jordanian citizen residing in Jordan.
- The Participant must be a “New Client” who opens a live trading account with the Company during the Campaign Period.
- The Participant must deposit a minimum of USD 100 into their trading account during the Campaign Period.
- The Participant must place their first trade during the Campaign Period.
- The Participant must provide the Company when registering for this Campaign with their full name, a valid phone number, and a valid email address.
- Only one entry per client is allowed; multiple entries via different trading accounts by the same client will be disqualified.
- The Participant must be eligible to apply for a visa and travel to United Arab Emirates.
- The Company reserves the right to disqualify any participation that does not comply by these terms and conditions and/or the Company’s policies, terms, or conditions and/or the Company’s proper KYC.

- In the event that any Client engages in any unacceptable trading practice, any form of market manipulation, or any activity that contradicts the Company's policies, terms, or conditions specified in the contract signed between the Company and the Client and any terms, instructions, and policies annexed to this contract by virtue of applicable laws, including but not limited to opening and closing or hedging any position(s) within three minutes, INGOT Brokers shall have the right, under its sole discretion and without any liability whatsoever towards the Client, to take any action it deems necessary for mitigating or preventing such a behavior and/or to exclude the trade in question from participating in the Campaign.
- Employees, contractors, agents, and immediate family members of the Company's employees are not eligible to participate in the Campaign.

#### **4. Announcement and Participation**

- The Company will announce the Campaign through advertising screens in public roads, on the Company's social media platforms, and through the Company's advertising campaigns. Through the published post, the Company will share a link redirecting New Clients to the Company's website prompting them to open an account with the Company; after New Clients open their trading accounts, they must verify them and fulfill the remaining conditions mentioned in the clause above during the Campaign Period.
- By clicking on the link, opening a trading account, and fulfilling the remaining conditions mentioned in clause three above during the Campaign Period, the Participants will automatically participate the Campaign and enter the draw.

#### **5. The Prize**

The prize is a 3-day, 2-night trip to Dubai, U.A.E., for two people (the winner and a plus one, including two round-trip tickets to and from Dubai on the economy class with Royal Jordanian, visa processing fees, and a stay at a 4-star hotel for two people (double room), morning breakfast included.

#### **6. Winner Selection**

- The Company will draw a random winner's name at the Ministry of Industry, Trade and Supply premises on April 3<sup>rd</sup>, 2024.
- The prize shall be delivered to the winner withing 30 days of announcing their name. In the event of a no-show during this period, the winner will lose their right to the prize and be excluded from the following draw.
- In the event of a no-show as mentioned above, the draw will be repeated for the same prize and with the same procedures and conditions as the first draw.
- In the event of a no-show for the second draw during the specified period, the prize will be cancelled.
- The prize is valid for three months excluding official holidays, which means that the winner cannot use the prize during official holidays.
- The winner will be notified via email at the email address associated with their trading account and/or via a phone call within seven days of announcing the winner. Participants must therefore provide the Company with a valid email address and phone number.

**7. Announcing the Winner**

The winner will be announced on the Company's official social media channels and through a daily local newspaper's announcement within (5) business days following the draw and winner announcement.

**8. Privacy**

By participating in this Campaign, the Participants agree to the Company's privacy policy, which can be found on the Company's website.

**9. Limitation of Liability**

The Company shall not be liable for any loss or damage suffered by Participants or the winner due to their participation in the Campaign or their use of the prize.

**10. Photos and personal information**

By participating in the Campaign, the Participants and the winner grant the Company separately an irrevocable right and permission to collect the Participants' and winner's personal information and photograph and/or record the Participants and/or the winner for promotional and marketing purposes related to the Campaign without any further compensation. Participants and the winner waive any right to inspect or approve the use of the personal information and/or photograph and/or recording and acknowledge and agree that the rights granted in this statement are without compensation of any kind.

**11. Governing Law and Jurisdiction**

These Terms and Conditions shall be governed by and construed in accordance with the laws of the Hashemite Kingdom of Jordan. Any dispute arising under or in connection with these Terms and Conditions shall be subject to the exclusive jurisdiction of the courts of the Hashemite Kingdom of Jordan.
